Compliance

Challenge

Government agencies and the Global Food Safety Initiative (GFSI) programs require food processors to have protocols and procedures in place for sanitation, critical control points, operating procedures and more.

As a result of the washdown environment, food processors previously had to minimize signage on the production floor to ensure food safety. That means that protocols and procedures had to reside in binders on office shelves far away from the processing floor, where employees could seldom read or see them.



Reinforcement cues

One way to improve compliance and increase awareness of safety protocols is to reinforce these messages with visual cues on the processing floor. This is effectively done with the use of Brady's ToughWash™ washdown-resistant, metal-detectable labels, signs, placards and tags. Visuals can include:
